Report on 2018 Accomplishments

Land Preservation

In 2018, we exceeded our goal of 15 preservation and acquisition transactions, with **42 transactions**, for a total of **2,870 acres preserved throughout the state**. These include preserved family farms and natural areas that safeguard clean drinking water, produce local foods, and provide wildlife habitat, scenic beauty and outdoor recreation.

2018 Land Preservation Highlights



Menantico Preserve - In August we acquired 600 acres of wetlands and forest along the Menantico Creek in Vineland. The Menantico Preserve is open to the public for outdoor recreation, environmental education, and wildlife habitat. This property boasts at least seven endangered, threatened and special concern listed animal species, including bald eagle,

red-headed woodpecker, barred owl and Cope's gray tree frog. The preserve is less than 5 miles from Vineland and a short distance from Millville, which together have a population of nearly 90,000 residents and a real need for more public open space.

Cowtown Rodeo - In March, we permanently preserved more than 450 acres surrounding Salem County's famous Cowtown Rodeo – the country's oldest weekly rodeo, which has been in operation since 1929. Because these lands are used primarily for breeding, raising and grazing of rodeo horses and cattle, they include some of the best grassland habitat in the state. Preservation will also help prevent development that could undermine the agricultural viability of this community, which is also an important agri-tourism destination. This



is a great example of farmland preservation using the Natural Resources Conservation Service's Agricultural Conservation Easement Program.



Thompson/Wright - In August, we acquired **460 acres in Southampton and Woodland Townships** in Burlington County to permanently protect extensive wetland, upland forest, water quality and wildlife habitat. The Burrs Mill Brook, a tributary of the Rancocas Creek and a pristine Pine Barrens stream, runs through the property, a former cranberry farm. Because the cranberry bogs were not modernized and have not been actively farmed since 2004,

they are naturally reverting to outstanding wetland habitat. The property is open to the public for passive recreation, including hiking, birding and nature observation. Existing sand roads bordering the former cranberry bogs offer stunning views of wetland habitats and form the basis of a future trail system.

Pelio – In July, we helped preserve the 244-acre Pelio property in **Lebanon Township**, Hunterdon County. This important open space preservation project, managed as part of the Hunterdon County Park System, links 2,600 acres of preserved forests, wetlands, streams and farms across northern Hunterdon County and neighboring Morris County. It is open to the public for passive recreation such as hiking, bird watching, mountain biking, cross-country skiing and nature observation.



Other Land Preservation Activities in 2018

- In August, we acquired 130 acres of large farm fields, mixed hardwood forest and forested wetlands along the pristine Wickecheoke Creek in **Stockton** – permanently preserved as

open space. The property is open to the public for passive recreation, including hiking, dog walking and nature observation.

- We helped preserve three farms in **Alloway Township** totaling nearly 100 acres. The three family help protect local water quality, wetlands and wildlife.
- In October, we added 11 acres of open space to the **Mount Rose Preserve in Hopewell Township**. The land is located at the center of the preserve, where a large conference center/hotel was demolished and restored to open space.
- In January, we helped preserve 53 acres in **Tewksbury Township**, adding to a growing greenbelt surrounding Oldwick village.
- We also continued to improve and promote the **NJ Conservation Blueprint** online mapping project with The Nature Conservancy and Rowan University. The NJ Conservation Blueprint mapping system combines data from state and federal agencies, and New Jersey's nonprofit land trusts, to allow for a more coordinated, strategic approach to identify and preserve the best of the Garden State.

Advocacy

New Jersey Conservation Foundation strives to **promote and defend public policies** that protect the land and natural resources of New Jersey with integrity and transparency. We work to preserve the permanence of land preservation, further land preservation and natural resource protection through policy actions, promote stable sources of government funding, and strengthen citizen conservation advocacy.

Our Advocacy staff helped develop several reports that influenced Governor Murphy's Transition Advisory Committee **recommendations for accomplishing environmental and energy priorities**, including focusing on clean energy, climate change, environmental justice, and protecting water and other natural resources. We also worked to **educate new NJDEP leadership** on the need for a more visionary, comprehensive approach to **managing forested state lands** that will protect rare, threatened and endangered plants and animals, mature continuous forests, water quality, and public scenic and recreational values.




We continued a comprehensive communications effort through Rethink Energy NJ, educating the public and decisionmakers about the importance of **stopping damaging fossil fuel projects** and ensuring a swift transition to clean, renewable and efficient

energy, and away from further reliance on fossil fuels and pipelines. We coordinated with our partners to promote effective implementation of the New Jersey Clean Energy bill and executive order, and met with senior staff in the Governor's office to discuss these issues. We also served on a panel at a forum held by NJ Spotlight on modernizing New Jersey's energy infrastructure.

Throughout 2018, we worked to **establish permanent sources of public funding** for land conservation at both the federal and state levels.

- Land and Water Conservation Fund – We advocated to secure permanent re-authorization and full funding of the Land and Water Conservation Fund, which provides funds for conservation and recreation at the federal, state and local levels.

- 2018 Farm Bill - Throughout 2018, we strongly advocated to retain conservation provisions in the 2018 Federal Farm Bill. These provisions would promote natural resource protections on preserved farms to protect our soil so that the agricultural soils of today will be available to grow food tomorrow.
- Land Preservation Funding – We worked as part of the Keep It Green Coalition on the new enabling legislation that will guide state expenditures for open space, farmland and historic preservation.



We used our "Environmental Principles" initiative to guide our advocacy work with the New Jersey Congressional delegation. We continue to use the Principles as a framework for expanded engagement with New Jersey's congressional representatives on issues core to our mission. We issued action alerts on conservation funding and proposed rollbacks to federal level protections.

Other Advocacy Activities in 2018

- We continued our efforts to defeat the PennEast pipeline and a growing list of unplanned, unneeded energy infrastructure proposals.
- Partnering with the Natural Resource Defense Council and local mayors and other conservation organizations, we renewed our efforts to pass state legislation to permanently protect the Palisades Cliffs.
- We continued working to draft new rules for State Farmland Preservation Program's Nonprofit Program.
- In the fall, we provided expert testimony to the Board of Public Utilities regarding development of a new Energy Master Plan to achieve 100% clean energy by 2050.
- In September, we released a 4th annual professional poll of voter attitudes on energy issues. The poll showed that New Jersey residents overwhelmingly support renewable energy, and want the state to achieve 100% clean energy by 2050.

Stewardship

In 2018, we continued to manage more than **27,000 acres** of land and conservation easements, including **19 preserves** that are open to the public. These preserves contain trails and associated amenities for walking, biking, horseback riding, bird watching, fishing, boating, and other recreational activities.

2018 Stewardship Highlights

At **Gateway Park** in Camden, we hosted a tree planting, where dozens of volunteers hand-planted trees, using shovels and sheer will-power, to help manage stormwater and runoff at the park. This 25-acre



tidal, riverfront park on the Cooper River provides public access for community residents and visitors, along with passive recreational activities and educational programs.

At the **Franklin Parker Preserve** in Chatsworth, we developed and installed beaver pipe that are used to prevent beaver from creating dangerous or damaging flooding conditions, while allowing them to build dams and utilize the 1,100 acres of restored wetlands at the Preserve. We also replaced an important spillway that controls the hydrology of approximately 80 acres of restored wetlands.



At our **Candace McKee Ashmun Preserve** in the Forked River Mountain Area of Ocean County, our stewardship staff worked to reduce illegal and highly damaging off-road motor vehicle access to the Preserve. Having the area closed to off-road motor vehicles will allow us to protect the preserve from future damage, as well as perform necessary restoration work. In May, we **planted native trees and shrubs** in areas that had been protected from off-road traffic. These plantings will augment natural revegetation and stabilize the soil in areas that had been significantly disturbed by off-road vehicles.



Other Stewardship Activities in 2018

- We maintained over 50 miles of trails on our preserves all across the state.
- We inspected our preserved lands to ensure compliance with Land Trust Alliance Standards and Practices.
- Removed invasive plants and replaced with native species.

Education

New Jersey Conservation Foundation is committed to bringing together the conservation community to share successful strategies and to learn new ways to accomplish conservation goals. We also enjoy sharing our knowledge, expertise and passion for New Jersey's natural areas with others. Widespread public awareness, understanding and appreciation of New Jersey's special places, its natural resources and ecological systems are critical to our State's economy, society and future quality of life.

2018 Education Highlights



Four hundred people attended our March **2018 New Jersey Land Conservation Rally** in New Brunswick. The keynote speaker, David Case, presented his findings from a national study of Americans and their attitudes and behavior towards the natural world. He inspired the audience by sharing that even though Americans are spending less time outdoors, they want to spend more time and think that the outdoor environment is very important to them. The thirty exhibit spaces were sold out, including a farmers' market that sold New Jersey honey, oatmeal and pussywillows.

In October, we presented a workshop titled *New Jersey's Conservation Blueprint: Prioritizing the Last Million Acres* at the **National Land Trust Alliance Rally** in Pittsburgh. The workshop discussed how collaboration within the land conservation community can result in accelerating the pace and quality of preserving the best of the state's remaining lands.

Other Education Activities in 2018

- Hosted 6 meetings of the **New Jersey Land Trust Network** in partnership with the Watershed Institute, for an aggregated audience of approximately 160 people.
- In June, we awarded 19 grants, totaling \$40,320, for the 2018 **Franklin Parker Conservation Excellence Grant program**, which awards money to New Jersey conservation nonprofits to enhance proficiency in land conservation, develop long-term viable programs, and support creative, innovative projects that can serve as models for other communities and projects.

Report on 2018 Accomplishments

- Continued to serve as a **statewide Land Trust Service Center**, bringing information and resources from Land Trust Alliance and other partners across the country to help New Jersey's conservation community thrive.
- Hosted over 580 participants in our signature **Step Into Nature events**: a series of 16 guided outdoor activities on preserved lands.

For the past 48 years, NJ Conservation has published *The State We're In*, a weekly column written by our Executive Director, about timely topics within the environmental scene in New Jersey. The column uses a science-based approach to educate the public about key conservation issues and natural resource threats in order to inspire public action. The column has been used successfully to influence legislation and policy on the state, regional, county and municipal levels; shine a spotlight on programs and projects worthy of recognition; and to point out gaps in New Jersey's environmental protections and suggest solutions.
